### **Terms and Conditions**

1. The "breeding season" referred to in this contract begins January 1st and ends \_\_\_\_\_ of the year stated above.
2. Pennwoods Percherons will ship semen from the above named stallion as many times as needed during the above stated "breeding season".
3. Pennwoods Percherons' responsibility to this contract ends when the below named mare becomes pregnant or when the active breeding season ends.
4. Mares that do not conceive in the current breeding season will be given return privileges for the following season, **only if we are informed of the "barren" status before the end of the current breeding season.**
5. **Pennwoods Percherons does not offer any type of live-foal guarantee.**
6. The stud fee for the above named stallion is \$ \_\_\_\_\_ and is due before any shipments are made.
7. A \$200.00 container deposit is also due with the stud fee. All semen transportation charges will be deducted from this deposit and the balance will be refunded upon return of all containers and of the Delivery Certificate signed by a licensed Veterinarian.
8. A \$25.00 collection and handling fee per shipment will also be charged and deducted from the deposit.
9. Pennwoods Percherons assumes responsibility only to deliver semen in viable condition at the time of delivery to the mare owner's farm or other designated location. The semen must be administered by a licensed Veterinarian.
10. This contract shall be interpreted in accordance with the laws of the Commonwealth of Pennsylvania and its validity and administration shall be governed by said laws.
11. The parties agree that the terms and conditions stated herein set forth the entire agreement of the parties.
12. I understand that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whether by death, injury, infection or otherwise, and by any cause whatsoever, and therefore agrees to hold Pennwoods Percherons, Chad and Rhonda Cole, and any other person employed by, or associated with Pennwoods Percherons, harmless, for any and all damages associated therewith.
